1. CALL TO ORDER: The meeting was called to order by Commissioner McHale at 9:04 a.m.

3. **SETTING OF AGENDA:** The Agenda was set as presented.

4. PUBLIC COMMENT: None.

- **5. STAFF RECOGNITION:** Staffers Cathy Cameron and Duane Shaffer were recognized by the Board for fifteen years of service to the Library.
- **6. SECRETARY'S REPORT:** Commissioner Uhler presented the Minutes from June, 24, 2021 Regular Board Meeting, which were approved as presented.
- 7. TREASURER'S REPORT: Commissioner Zahorchak reviewed the June, 2021 financial reports for the Board. Of note, cash is down as expected this time of the year most of the tax revenue has been received for the current fiscal year; vacation accruals indicate that staff need to schedule vacations; depreciation will be calculated at fiscal year-end; timing issues noted in some area with Covid having an impact on the year to date expenses. Financial reports will be held for audit.

8. PRELIMINARY BUDGET 2021-2022 PRESENTATION:

The Preliminary Budget 2021-22 was presented by Executive Director Mohundro and Clerk Cameron. Discussion was heard including: increase in home values; increase in cost of living, inflation; keeping slippage rate at 4%; keeping millage rate at current rate of .000435; line by line review of items; capital outlay items; adding back two part-time positions which is included in the budget calculation; review of SEP which is presently capped by the Board and how it will impact staff as additional employees become eligible. Budget discussion will continue.

A motion was made by Commissioner Uhler seconded by Commissioner Ruben approving the Preliminary Millage Rate 2021-2022 of .000435 (.4350 mills). The motion was approved unanimously by voice vote.
