4. Presentation and Review of Final Budget 2023-24

The Tentative Budget Hearing Minutes were reviewed and accepted as presented.

The Final Budget and Millage Rate were presented and reviewed by Treasurer Sandy Zahorchak.

*A motion was made approving the Millage Rate of .5667mills and Budget of \$2,390,348 as presented by Commissioner Congress, seconded by Commissioner Zahorchak; the motion passed unanimously by voice vote. Votes were recorded as follows: YES – Commissioner Congress, Commissioner Zahorchak, Commissioner Greggs, Commissioner Gibson, Commissioner Uhler; NAY – there were none.*

5. RESOLUTION 2023-03, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR SANIBEL PUBLIC LIBRARY DISTRICT, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2023-24, reflecting a millage rate of 0.5667 mills, which is greater than the rolled-back rate of .3642 by 55.60% was read into the record by Commissioner Congress.

*A motion was made by Commissioner Gibson, seconded by Commissioner Greggs adopting Resolution Number 2023-01, the 2023-24 Final Millage Rate at .5667. Duly adopted by voice vote at 5:17 P.M. 6. RESOLUTION 2023-04, ADOPTING THE FINAL BUDGET FOR THE SANIBEL PUBLIC LIBRARY DISTRICT OF SANIBEL, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2023-24; PROVIDING FOR AN EFFECTIVE DATE reflecting \$2,390,348 was read into the record by Commissioner Congress.
