3. Public Comment: Mr. Ronald Purdy of Sanibel was in attendance. Mr. Purdy voiced concern as to the State's promise on rebates to municipalities. The Board confirmed to Mr. Purdy that this is the Sanibel Public Library District Tentative Budget Hearing and the Library Board will decide on the Library's millage rate only.

4. Presentation and Review of Tentative Budget 2023-24

The Tentative Budget and Millage Rate were presented and reviewed by Treasurer Sandy Zahorchak.

5. **RESOLUTION 2023-02, ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR SANIBEL PUBLIC LIBRARY DISTRICT, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2023-24, reflecting a millage rate of 0.5667 mills, which is greater than the rolled-back rate of .3642 by 55.60% was read into the record by Commissioner Zahorchak.**

A motion was made by Commissioner Congress, seconded by Commissioner Greggs seconded by Commissioner --- adopting Resolution Number 2023-01, the 2023-24 Tentative Millage Rate at .5667. Duly adopted by voice vote at 6:27 P.M. Votes were recorded as follows: YES –Commissioner Gibson, Commissioner Zahorchak, Commissioner McHale, Commissioner Congress. NAY – none.

6. **RESOLUTION 2023-01, ADOPTING THE TENTATIVE BUDGET FOR THE SANIBEL PUBLIC LIBRARY DISTRICT OF SANIBEL, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2023-24; PROVIDING FOR AN EFFECTIVE DATE reflecting \$2,390,348 was read into the record by Commissioner Zahorchak.**



NOW, THEREFORE, BE IT RESOLVED by the Sanibel Public Library District of Sanibel, Lee County, Florida, that:

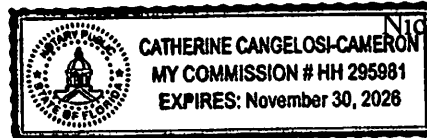
1. The FY 2023-24 operating millage rate is 0.5667 mills, which is greater than the rolled-back rate of .3642 by 55.60%

WHEREAS, the Sanibel Public Library District of Lee County, Florida, on September 12, 2023 held a public hearing as required by Florida Statute 200.065; and

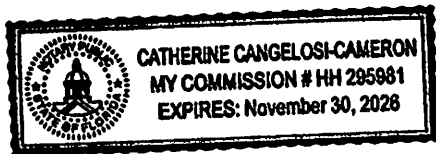


NOW, THEREFORE, BE IT RESOLVED by the Sanibel Public Library District of Lee County, Florida, that:



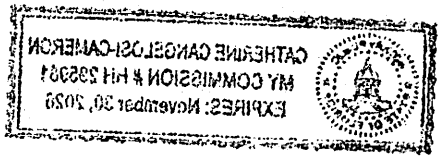
