The Tentative Budget was presented and reviewed by Chair, Melanie Congress


5. **RESOLUTION 2021-01, ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR SANIBEL PUBLIC LIBRARY DISTRICT, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2021-22, reflecting a millage rate of 0.4350 mills, which is greater than the rolled-back rate of .4256 by 2.21% was read into the record by Commissioner Congress.**

A motion was made by Commissioner Gibson seconded by Commissioner Ruben adopting Resolution Number 2021-01, the 2021-22 Tentative Millage Rate at .0004350. Duly adopted by voice vote at 5:20 P.M. Votes were recorded as follows: YES – Commissioner Ruben, Commissioner Gibson, Commissioner Zahorchak, Commissioner McHale, Commissioner Congress. NAY – none.

6. **RESOLUTION 2021-02, ADOPTING THE TENTATIVE BUDGET FOR THE SANIBEL PUBLIC LIBRARY DISTRICT OF SANIBEL, LEE COUNTY, FLORIDA, FOR FISCAL YEAR 2021-22; PROVIDING FOR AN EFFECTIVE DATE reflecting \$2,350,307 was read into the record by Commissioner Congress.**

A motion was made by Commissioner Gibson, seconded by Commissioner Ruben to adopt Resolution 2021-22, adopting the Tentative Budget for the Sanibel Public Library District as \$2,350,307.
